1. CATEGORIES OF DATA PROCESSED/LINKS TO OTHER WEBSITES/APPLICATIONS

Data marked with an asterisk (*) are mandatory and are required for the enjoyment of the website's services and to respond to your requests. Therefore, you are obliged to communicate them to us in order to pursue your request. Without providing this data, we will not be able to respond to it.

Depending on your profile and user behavior/statistics while browsing our website, you may be presented with a pop-up window offering you a test drive or a voucher for the model you are interested in.

NOBLELAND VENTURES INC. shall process your Personal Information in accordance with this Privacy Policy and on the User's explicit consent and/or as necessary for the pursuit of its website's legitimate services. Your personal data will be retained for ten years after you consent to its processing and shall only be used for the purpose/s it is obtained, for all acts reasonably necessary to achieve such purpose/s, and only for legitimate business purposes pursuant to the Sec. 11 of the Philippine Data Privacy Act of 2012 ("Data Privacy Act").

If you have given your consent for the use of your data for marketing purposes, your personal data will be kept for these purposes for three years after the last contact with us.
